**PLEASE NOTE:** It is the entrant's responsibility to read and comply with the following requirements:

**ELIGIBILITY & REQUIREMENTS**

- Must be a North Texas Resident and reside within a 125 mile radius of Allen, TX.
- Must be 18 years of age or older.
- Limit three (3) entries per contestant.
- Entries will be juried by JPEG image on disc. Each Image must be labeled with Title. Disc and disc envelope must be labeled with Artist name and mailing address. Disc will be returned to artist if a self addressed stamped return mailing envelope is provided.
- Artwork must have been completed within the last 24 mos.
- Artwork must be totally dry.
- Artwork must be mounted securely in frame with mirror brackets.  
Spring loaded clamps, claw clamps, or pressure clamps will not be accepted.  
Metal frames will be accepted as long as artwork is securely mounted in the frame.
- Gallery-wrapped canvas is acceptable.
- Watercolor and other fragile media must be under Plexiglas\*  
*\*Exception -Pastel ONLY will be accepted under glass.*
- Framed length or width cannot exceed 38"
- Entry must be Artist's original concept. If from a Photo, Photo must have been

- taken by the artist. Negative may be requested.
- Entries that originated through workshops or classes are not allowed.
  - No digital graphics or shadow boxes will be accepted in this competition.
  - No nudes or political statements.
  - Artwork must be displayed for duration of show.
  - Aurora Images Art Studio reserves the right to refuse any entry.
  - Items may not be not be labeled with sale price. Any sales inquiries will be directed to Aurora Images Art Studio. All sales will be conducted through Aurora Images Art Studio. Aurora Images Art Studio will retain 25% commission.
  - Awards are at the discretion of the juror.
  - Due to space limitations, 3 dimensional work must not exceed 20 lbs.

*Entry into this competition shall imply the artist's acceptance of the above policies.* The greatest possible care will be taken in handling works; however, Artist is responsible for obtaining their own insurance. The Coalition of Allied Visual Artists, Aurora Images Art Studio and/or the Allen Public Library will not be responsible for loss or damage of any work.  
Entry shall imply agreement by the artist.
